This is with reference to your online application dated 27/06/2012 on the subject cited above, I am directed to convey sanction for extension of provisional affiliation of the school with the Board for its Secondary School Examination and Senior School Certificate Examination for a period of Five years w.e.f. and 2013 to 31.03.2018 subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary and senior secondary classes:

1. The School is required to follow syllabi and course as per scheme of studies prescribed by the Board for the respective Examination.

2. The School is required to abide itself by the Examination/Affiliation-Bye-Laws of the Board.

The School is required to apply on online for further extension of affiliation alongwith the requisite fee and other documents by 30th June of the preceding year in which the Provisional Affiliation expires. Applications will be accepted after the last date along with the prescribed fee and late fee Rs. 10,000/- per month.(Amended Rule-15.11)

It is mandatory for every affiliated school to become a member in the local Sahodaya of CBSE schools. - b. The School Managing Committee is required to be reconstituted as per Affiliation Bye-laws by including representatives of teachers, parents and CBSE.

The School should be improve its financial status as the school is running in deficit during the last three years.

d. Enrollment of students in classes from XI to XII is low. Efforts should be made to increase the enrollment of students.

e. The school should furnish the EPF challan.
